How were Republican candidates evaluated?

<p>"Anti-choice" means the candidate does not support a woman's right to choose to have an abortion, such as:</p> <ul style="list-style-type: none"> - voting against Women's Health Protection Act (HR 8296) to protect abortion access (incumbents only) - describing him/herself as "pro-life" and/or supportive of SB 1 - accepting donations or endorsements from Right to Life and similar organizations 	<p>"Anti-gun safety" means the candidate opposes reasonable gun safety regulations, such as:</p> <ul style="list-style-type: none"> - voting against Bipartisan Safer Communities Act (S 2938) to reduce gun violence and fund mental health services (incumbents only) - voting against Assault Weapons Ban (HR 1808) (Incumbents only) - describing him/herself as "pro-2A" - indicating intention to reject gun control measures if elected - accepting donations or endorsements from the NRA and similar organizations 	<p>"Anti-democracy" means the candidate has shown support for people and ideals damaging to democracy, such as:</p> <ul style="list-style-type: none"> - support for Trump, his presidential agenda, current actions, and/or re-election - 2020 election denial; objected to certifying results of 2020 election - support for theocratical government
